#### **AFRICA**

#### **ANGOLA**

#### Protecting Freedom of Association ® \$ 50.000

To defend civic space and advocate for an enabling legal environment for non-governmental organizations, the organization will support a consortium of civil society groups to review the proposed law on non-governmental organizations, host regional roundtables and a national conference on rights and governance, and provide legal assistance to human rights defenders.

### Expanding Civic Education and Participation of Women in Politics (2) \$ 45,000

To increase civic participation of women in local governance, the organization will hold dialogues and training sessions to raise awareness, organize meetings with local government leaders to include women's voices in decision-making, and produce a magazine and documentary to expand its reach.

### Promoting Youth Civic Engagement 9 \$ 45,000

To promote youth civic participation and engagement, the organization will conduct training sessions in three municipalities on civic participation and leadership, using theater, film, documentaries, discussions, and radio programs to encourage youth involvement in democracy and governance.

## Developing Leadership Skills and Democratic Values for Youth (1) \$ 120,000

To empower youth with leadership capacity and democratic values, the organization will provide training, hold workshops with various stakeholders, and facilitate an exchange program for selected youth activists to learn from civic and political leaders in other countries about best practices in participatory governance.

# Increasing Citizen Participation in Promoting Transparency ① \$ 50,000

To empower citizens and promote transparency in the management of public funds, the organization will conduct training on monitoring the national budget and municipal investment programs, advocate for stronger civil society collaboration with municipal administrators, and hold community forums with municipal leaders to discuss progress and address governance challenges.

# Promoting Participatory and Transparent Governance ① \$ 45,000

To increase citizen participation in local public policy and promote transparent governance, the organization will hold training sessions and community discussions, while supporting citizen platforms to monitor local government activities and ensure accountability.

# Strengthening Civic Networks ① \$ 80.000

To increase citizen awareness and participation in decision-making processes and defend the rule of law, the organization will train its members, support local-level initiatives, document human rights violations against activists, and assist with the legal costs for human rights defenders.

# Promoting Freedom of Expression and of the Press \$\mathbb{Q}\$ 48.000

To promote freedom of expression, the organization will train individuals in citizen journalism, developing their interviewing and research skills on transparency, corruption, and human rights, and raise public awareness by sharing updates on local civil society activities through social media and online platforms.

## Protecting Human Rights Defenders ① \$ 70,000

To create an enabling environment for human rights defenders and activists and increase their capacity to counter closing civic space, the organization will strengthen its protection and defense of at-risk human rights defenders and create a solidarity network to provide rapid response support.

# Increasing Youth Civic Participation ① \$ 60,000

To build the capacity of youth to advocate for fundamental rights in their communities, the organization will hold workshops to help youth identify key issues, support them in developing advocacy campaigns, provide mentorship, and amplify their voices through digital platforms.

# Advancing Human Rights Protections ® \$55,000

To promote respect for and the protection of human rights in a conflict setting, the organization will document and report security incidents and violations, reinforce the capacity of lawyers to assist victims, develop policy briefs, advocate for human rights-protecting policies, and identify and litigate cases before regional and international mechanisms.

# Promoting Respect for Human Rights and Strengthening Access to Justice ① \$ 53.250

To strengthen the protection of human rights and access to justice for victims of abuses, the organization will enhance civil society's capacity to monitor and document security force abuses, equip human rights defenders to assist victims, and support community engagement efforts to encourage reporting of violations and advocate for security policies rooted in human rights.

## Advancing Democratic Values and Principles ® \$47.500

To empower youth to advocate for a return to democracy, the organization will equip young people with knowledge of democratic values, skills to monitor constitutional reform, conduct awareness-raising activities, and host debates on democracy and the draft constitution.

#### Strengthen Youth Capacity to Defend Human Rights and the Civic Space 9 \$ 60.000

To defend human rights and civic space, the organization will strengthen youth capacity to advocate for their rights, mobilize their community around democratic values, host regional convenings and awareness-raising activities, and facilitate the creation of youth networks to reclaim civic space.

#### **BURUNDI**

### Documenting Human Rights Abuses and Advocating for Justice ⑦ \$ 39.500

To raise awareness of human rights, the organization will maintain its network of monitors to document violations, publish reports, advocate for accountability for serious abuses, and submit cases to the UN Working Group on Enforced Disappearances.

#### Preventing Violence and Supporting Youth During the Electoral Cycle (1) \$ 60,000

To strengthen the capacity of key stakeholders to promote nonviolence and constructive dialogue throughout the electoral cycle, the organization will conduct dialogues with community leaders and youth affiliated with political parties to discuss tolerance and peace, foster linkages between youth and conflict resolution mechanisms, and provide legal support to at-risk groups.

# Strengthening Good Governance ① \$ 40,000

To improve governance and encourage greater accountability by women parliamentarians and elected officials, and to strengthen civic participation in elections, the organization will conduct trainings to help women officials respond to citizen demands, analyze, draft, and defend government budget provisions, and work with grassroots groups to implement civic education campaigns.

## Bolstering Independent Civil Society and Human Rights ® \$55,000

To equip civil society to advocate for human rights, the organization will monitor violations, support victims, provide legal assistance for cases referred to international mechanisms, and collaborate with civic actors and international stakeholders to develop common advocacy strategies for greater accountability.

## Fostering Youth Digital Engagement ① \$ 60,000

To strengthen the capacity of young journalists to contribute to freedom of expression and promote accountability, the organization will train a cohort of young journalists and produce blogs and video content on good governance, elections, and civic participation.

# Promoting Democratic Values ② \$ 46,092

To promote democratic values and community cohesion in areas with a history of political conflict, the organization will hold community dialogues with local leaders and youth to discuss inter-communal tensions, establish local committees to address conflict, conduct awareness-raising activities, and support formerly displaced young people to encourage their political participation.

## Strengthening Independent Media ① \$ 58.800

To strengthen freedom of expression by increasing access to information and independent reporting, the organization will maintain correspondents in refugee-hosting countries, support additional correspondents in border countries, expand coverage of women's political issues, and strengthen its security protocols.

## Envisioning a Model for Good Governance ① \$ 55.000

To counter corruption and economic mismanagement and expand civic and political space, the organization will monitor government spending and produce publicly available content to bring more transparency to public budgeting.

# Enhancing Women's Participation in Conflict Resolution ① \$77,500

To build the capacity of women to engage in conflict resolution and promote citizen engagement in community decision-making, the organization will launch a training program for women leaders on political participation, conflict resolution, and advocacy, and support their involvement in advocacy campaigns and roundtables to improve decision-making processes.

# Advancing Youth Participation in Promoting Peace ® \$48,000

To enhance youth capacity to build peace, the organization will host training workshops for youth leaders on conflict resolution, collaborate with them to produce short videos and written statements highlighting the conflict's impact on youth, and conduct advocacy with local leaders for a resolution to the conflict.

## Promoting Political Participation ② \$ 35.000

To enhance civic education and effective political participation, the organization will conduct a baseline survey to assess civic education gaps, use community radio to air programs on civic responsibility, and engage traditional authorities to advance the political participation of women and youth in the country's democratic processes.

## Promoting Youth Civic and Electoral Participation ® \$65,000

To educate and mobilize youth to participate in the 2025 elections and reduce electoral violence, the organization will launch a nonpartisan "Not Too Young to Vote" campaign to educate youth on their civic rights and responsibilities, hold public engagements to encourage election participation, and develop an interactive web page, toolkit, and newsletter on the electoral process.

## Advancing Youth Participation ® \$100,000

To promote youth inclusion in public affairs and freedom of expression, assembly, and association, the organization will host workshops to engage youth leaders and promote community peace, hold dialogues with elected officials, launch a nonpartisan voter registration and mobilization campaign to encourage youth voting and political engagement, and host a mentorship program for youth interested in running for office.

# Mobilizing and Empowering Citizens to Uphold Election Integrity @ \$ 75,000

To mobilize and empower young people to increase voter participation and safeguard the integrity of the upcoming elections, the organization will train a nonpartisan cohort of young democracy advocates on increasing voter turnout and ensuring fair elections, provide tools for citizens to observe and report on the electoral process, hold forums to promote civic participation, and engage lawyers to document civil and political rights violations.

#### Enhancing Access to Information and Ensuring Accountability During Elections ® 80,000

To strengthen the capacity of media and community leaders to ensure electoral integrity, the organization will collaborate with media professionals to inform citizens about the electoral process and support journalists, bloggers, and civil society leaders in researching and reporting on election-related issues.

## Increasing Citizen Participation in Elections ② \$ 50.000

To educate and mobilize women, youth, and people with disabilities for the 2025 election, the organization will host capacity-building trainings to enhance understanding of the electoral process, produce radio programs to promote voter registration, and encourage voter participation in the election.

## Promoting Youth Engagement and Leadership in Advancing Democratic Principles ① \$ 70.000

To promote youth and civil society participation in local governance and peace-building, the organization will host workshops to build the capacity of youth council members to participate in the local budgeting process, promote peace, and contribute to post-conflict reconstruction discussions.

# Supporting Peaceful Electoral Processes ① \$ 50,000

To foster citizen capacity for peaceful electoral processes, the organization will develop nonpartisan educational materials on the electoral process, train young election mediation champions, and deploy them to engage citizens in community dialogues advocating for peace before, during, and after the elections.

## Empowering Citizens to Responsibly Engage Online ® \$ 50,000

To build the capacity of community and civil society leaders to engage online communities, the organization will establish a network of focal points in four cities, promote digital literacy, and strengthen the capacity of community radio stations and journalists to publish engaging content.

#### Promoting Peace and Community Cohesion (2) \$ 64,900

To promote citizen participation in electoral and democratic processes to foster peace and community cohesion, the organization will conduct workshops for community leaders, engage religious and political leaders on political participation and how to promote religious and ethnic cohesion, establish a nonpartisan school of democracy for citizens, and coordinate a high-level peace forum.

# Promoting Youth Political Leadership ② \$ 60,000

To strengthen the political leadership capacity of young people and promote the political empowerment of young women, the organization will organize nonpartisan workshops and seminars for young political party leaders on youth political participation, political leadership, conflict resolution mechanisms, and tolerance.

# Supporting Public Debate and Local Civil Society ® \$55,000

To support public debate and local civil society, the organization will strengthen its platform for generating analyses and recommendations informed by citizens' perspectives, organize forums for civil society organizations to exchange ideas, and map civil society work in three cities to provide national and international actors with a nuanced understanding of local dynamics.

#### CHAD

## Supporting Citizen Election Monitoring ③ \$ 223.000

To establish an independent, nonpartisan election monitoring coalition for the 2024 presidential and legislative elections, the coalition will build the capacity of its members to train, equip, and deploy two thousand election monitors and human rights watchers to document and report serious electoral irregularities and human rights violations across ten major cities.

## Advancing Civic Education and Women's Political Participation ® \$65,000

To promote civic education and women's political participation in southern Chad, the organization will conduct capacity-building trainings and public forums for youth and women-focused organizations, media representatives, religious leaders, and local officials on electoral civic education and women's political empowerment, and produce a bi-weekly radio program to raise public awareness on core democratic values.

#### Protecting Human Rights During the Political Transition and Electoral Process ® \$65.000

To monitor, document, and report human rights violations committed during the political transition and electoral process, the organization will publish and share reports on human rights with local and international networks, strengthen the capacity of civil society leaders and independent journalists to investigate and report on violations, and engage law enforcement officials on protecting human rights and civil liberties.

# Strengthening Freedom of Expression During Political Transition ① \$ 65,000

To reinforce freedom of expression and ensure greater citizen participation during political transition, the organization will train investigative journalists, civil society actors, and human rights defenders on techniques to monitor freedom of expression violations, develop partnerships with independent media institutions, civil society organizations, and human rights platforms, and produce relevant radio programs.

# Strengthening Women's Political Participation ② \$ 130,000

To promote women's political participation, the organization will hold capacity-building workshops, establish mentoring and networking programs, conduct evidence-based research projects, launch public education and awareness campaigns, and conduct advocacy initiatives with newly elected legislators to promote women's political participation and protect women's political rights.

#### **CÔTE D'IVOIRE**

## Promoting Nonviolence and Transparency in the Electoral Process 1 \$ 70.000

To strengthen civil society and local government capacity to prevent violence during the electoral cycle, the organization will implement workshops for community leaders and local government authorities to develop strategies for preventing violence, strengthen early warning systems, support local monitoring committees, and synthesize findings after the election.

#### Advancing Peaceful Elections and Women's Political Participation ® \$33,000

To prevent conflict and promote the participation of young women in civic life, the organization will train local young women leaders and traditional, religious, and administrative authorities on the electoral process, hold community and family dialogues to raise awareness on democratic culture, and work with local peace clubs in three communities with a history of electoral violence.

#### Supporting Democratic Initiatives for Peaceful and Free Elections ${\scriptsize \textcircled{1}}$ \$ 60.000

To promote peaceful and free elections, the organization will train young activists in democratic and civic values, conduct bi-monthly citizen debates on political issues and the importance of peace and tolerance, broadcast messages on democratic values and non-violence via community radio and social media, and monitor online violence against women involved in politics.

# Promoting Peaceful and Informed Electoral Participation ① \$ 60,000

To advance peaceful and informed electoral participation, the organization will establish local citizen watch committees to enhance electoral transparency, educate youth leaders and communities on responsible election discourse and reporting, and collaborate with leaders to apply their skills in reducing electoral tensions.

#### **DEMOCRATIC REPUBLIC OF CONGO**

## Engaging Youth Leaders in the Democratic Process 6 \$ 30.000

To promote youth representation and participation in the democratic process, the organization will host training sessions for youth leaders on democratic values, advocacy techniques, and leadership skills, and facilitate training and coaching for youth participating in elections as candidates, poll workers, or election observers.

# Promoting Citizen Participation in Elections and Defending Human Rights ① \$70,000

To strengthen civic and political participation in elections and defend basic human rights, the organization will conduct workshops and panel discussions on political rights and electoral participation, hold citizen forums and town hall meetings, and publish reports on the human rights situation during elections.

## Promoting Women's Political Participation in Elections ② \$ 68.140

To strengthen women's political participation in elections, the organization will hold mass outreach activities, women's leadership training sessions, public forums and town hall meetings, and produce radio programs to educate women on electoral issues and increase their interest in politics.

# Promoting Women's Political Participation and Advancing Electoral Integrity ① \$75,000

To promote women's political participation and electoral integrity, the organization will launch a civic education campaign to inform citizens about the electoral process and encourage women to take an active role in public affairs, and advocate with local officials through the "My Vote is Not for Sale" campaign to document and denounce electoral corruption.

# **Supporting Human Rights Documentation and Monitoring** \$70,000

To improve reporting on human rights and to better inform the public and international actors about human rights in the country, the organization will provide strengthen the ability of human rights defenders and journalists to monitor, document, and report on human rights violations, develop a database of human rights cases, and support advocacy and awareness-raising campaigns.

## Combating High-Level Corruption ① \$ 75,000

To combat high-level corruption and advocate for greater accountability in the resource extraction industries, the organization will monitor and investigate three grand corruption cases related to financial crimes, develop civic mobilization campaigns, and monitor the process and outcome of mineral agreements and their deployment.

# Strengthening Citizen Oversight <sup>(1)</sup> \$ 63,533

To deepen citizen engagement and oversight of the extractives sector, the organization will conduct research and analysis of mining revenue financial flows and their relation to government budgets, and strengthen the capacity of civil society actors to engage government officials, companies, and other stakeholders in constructive dialogue on local development plans and the management of public funds.

#### Empowering Youth to Defend Rights and Advocate for Change \$ 57.500

To enhance the capacity of youth organizations and their leaders to advocate for youth rights and drive positive change in local communities, the organization will host interactive workshops on democratic processes, civic engagement, and communication, and conduct research on critical community issues sharing the findings with elected officials, policymakers, and the public.

## Strengthening Youth Capacity to Promote Nonviolence ① \$70,000

To promote peaceful youth participation in elections, the organization will conduct research on the causes and consequences of youth political violence in presidential electoral cycles, use the findings to inform youth training workshops and engagement with local authorities, and collaborate with local youth to conduct awareness-raising campaigns, radio programs, and public cultural events promoting nonviolence.

## Supporting Freedom of Expression to Build Accountability ① \$70.000

To promote freedom of expression and citizen oversight of government, the organization will conduct capacity-strengthening activities for media on conflict-sensitive reporting and Combating community tensions, advocate for better protections for journalists, and produce quality independent journalism on the electoral cycle, the management of public affairs, and conflict.

#### Preventing Conflict and Advocating for Democratic Reform ① \$ 65.000

To build the capacity of communities to avoid conflict and advocate for democratic governance reforms, the organization will strengthen community resilience through peacebuilding workshops and inter-community dialogue, launch awareness campaigns to promote civic engagement, and conduct targeted advocacy with newly-elected lawmakers on democratic reforms responsive to citizens' needs and interests.

# Supporting Provincial Institutions to Improve Democratic Governance ① \$75,000

To support good governance best practices and to strengthen the capacity of provincial assembly deputies and the provincial executive, the organization will empower civil society with information to hold elected officials accountable and in formulating advocacy strategies, support civil society to formulate advocacy strategies and become involved in local policy development, and raise community awareness on laws and regulations guiding local elections.

# Strengthening Local Governance and Youth Participation ① \$ 52,500

To strengthen local democratic governance and youth participation, the organization will build the capacity of local government leaders, civil society actors, and young people from political parties and citizen movements to combat corruption and encourage responsive leadership, and organize a mentoring program for young political leaders.

## Strengthening Community-Government Partnership on Security Sector Governance @ \$ 72,500

To strengthen collaboration between local community leaders and government officials to improve public security sector governance, the organization will conduct workshops on security sector budget planning, support sector assessment missions, facilitate town hall forums, and produce monthly reports on political, judicial, and security issues.

## Advocating for the Rights of Vulnerable Communities **(2)** \$ 200,000

To empower grassroots leaders and activists to engage with government and non-state actors to defend the rights of communities affected by natural resource extraction projects, the organization will partner with a local group to co-design and launch an annual training program that equips young activists and rights defenders with innovative knowledge, advocacy tools, campaign techniques, and legal strategies to defend the rights and interests of communities impacted by mining.

#### Strengthening Democracy in Online Civic Spaces ① \$ 60.000

To strengthen online civic spaces for more informed and responsible citizen participation, the organization will implement community education initiatives to build media awareness skills, partner with journalists to strengthen their capacity to identify and verify inaccurate information, and produce content in various formats to reach a larger audience.

# Promoting Human Rights for Improved Governance ® \$ 48,750

To strengthen the capacity of rural populations to monitor human rights and promote good governance, the organization will assist a network of monitors to document human rights violations in conflict-affected areas, hold workshops and town halls to encourage collaboration in violence prevention and strengthen accountability, and produce regular reports to raise awareness of rights violations and atrocities.

# Strengthening Transparency and Accountability in Natural Resource Governance ① \$ 97,500

To strengthen transparency in the management of natural resources and ensure effective accountability, the organization will conduct public research on citizen participation in resource revenue management, facilitate community dialogues and meetings to build accountability mechanisms, promote transparency between the public, government, and private sector, and establish local structures to address conflicts related to natural resources.

## Advancing Citizen Oversight and Democratic Processes ® 70,000

To reinforce citizen oversight of government institutions and advocate for needed reforms at local and national levels, the organization will strengthen citizen advocacy, provide opportunities for direct engagement with elected officials and government institutions, and support awareness-raising initiatives around potential reforms.

# Strengthening Mechanisms to Safeguard Human Rights ① \$70,000

To strengthen mechanisms to protect and promote human rights, the organization will establish community-led reporting hubs to document, investigate, and report human rights violations, publish reports to inform the public and policymakers, and advocate with officials to improve human rights conditions.

# Advancing Press Freedom ① \$ 65,000

To defend press freedom and strengthen the capacity of independent media, the organization will monitor violence against journalists, trials, and visits to detained journalists, publish reports and hold press conferences on press freedom violations, and conduct workshops to promote independent and ethical community-centered journalism.

#### Fostering Accountability in Public Affairs Through Investigative Journalism ① \$ 65.000

To foster accountability in public affairs through investigative journalism, the organization will investigate and publish monthly reports on the execution of the national budget and major public projects, monitor mining revenue reports, highlight investigations by the general accounting office, and organize workshops for journalists to strengthen their capacity to investigate corruption.

# Strengthening Transparency and Access to Information to Foster Accountability @ \$ 70.000

To improve transparency and access to information to promote accountability, the organization will organize workshops for youth to learn how to use innovative tools to access and analyze publicly available government data, and develop an application to conduct audits of public data on education and public finances to detect potential cases of corruption.

# Investigating Public Funds Allocation for Local Infrastructure Projects ② \$ 65.000

To investigate public funds allocation for local infrastructure projects, the organization will examine how funds linked to infrastructure in four provinces are managed and their impact on local communities, disseminate the findings through the media and local forums, and advocate for greater accountability and citizen oversight.

## Promoting Citizen Participation and Oversight of the Parliament @ \$ 70.000

To promote citizen participation and oversight in the parliamentary decision-making process, the organization will monitor parliamentary work and debates on reforms, use a digital platform to promote citizen monitoring to enhance transparency and accountability, and hold forums with parliamentarians and citizens to produce bills and parliamentary initiatives.

# Combating Corruption in the Artisanal Mining Sector ® \$ 50,000

To expose and fight corruption in the artisanal mining sector, the organization will investigate and document cases of corruption and conflicts of interest involving local authorities in copper and cobaltrich areas, engage with mining enterprises and governmental entities to advocate for sector formalization, and conduct training workshops for artisanal miners to reinforce their understanding of their rights and obligations.

## Preparing for Democratic Elections ② \$ 75,000

To promote a comprehensive reform framework to strengthen electoral processes, the organization will establish a task force to evaluate electoral system laws and institutions, propose electoral reform measures, strengthen the capacity of parliamentarians to advocate for reform, and launch national civic education campaigns to create spaces for dialogue between lawmakers and citizens.

## Combating Corruption and Advancing Accountability ① \$80.000

To combat corruption and promote accountability in government institutions, the organization will research policies on public salaries and benefits, issue policy recommendations, launch nationwide awareness campaigns to drive public demand for reform, and introduce an annual award to honor anti-corruption heroes.

# Advocating for Electoral Reforms <sup>(1)</sup> \$ 70,000

To advocate for electoral reforms and promote civic and electoral education, the organization will launch a national civic education campaign to increase political participation across provinces, establish an independent, nonpartisan mission to monitor elections and identify irregularities, and recommend key reforms to the electoral process.

# Advancing Community Initiatives for Human Rights ① \$70,000

To empower and engage citizens in human rights oversight in their communities, the organization will host dialogues to mobilize community members, develop strategies to amplify their concerns, establish or leverage community-based early-warning measures, and protect citizens and human rights defenders.

## Advancing Active Citizenship ① \$72,500

To promote citizen participation through grassroots civic education and community mobilization, the organization will convene national meetings on citizen participation, peacebuilding, and governance, host forums and conferences to educate citizens and encourage public participation, and support interactive radio programs to foster dialogue and increase citizen involvement in governance.

## Strengthening Local Government and Civil Society Engagement to Improve Governance ① \$ 65,000

To strengthen the capacity of local authorities and empower civil society leaders for effective democratic governance, the organization will train local councilors and community leaders to improve local governance, create a dialogue platform to enhance interaction between local authorities, civil society, and community members, and launch a civic rights and governance mentorship program.

# Advancing Public Support for Electoral Reform ② \$ 80.000

# Promoting Investigative Reporting and Access to Information ① \$80,000

## Supporting Open Parliament Engagements and Networking ① \$ 150,000

To advance parliamentary transparency and accountability across national and regional legislatures, the organization will conduct legislative performance assessments, advocacy skills workshops for parliamentary monitors, create a legislative transparency index and online resource hub, and deploy monitors to regional parliamentary bodies.

# Advancing Media Freedom ② \$ 120,000

To strengthen media freedom, the organization will enhance collaboration among media freedom groups, build their advocacy capacity, and work with the Economic Community of West African States to promote media freedom within its democracy mandate, while also launching national-level media freedom campaigns.
