#### AFGHANISTAN

# Promoting Free Expression 9 \$ 525.000

To promote free expression and democratic values, the organization will operate an independent satellite TV channel providing news, analysis, and cultural programs, serving as a platform for civil society to advocate for democracy, human rights, and social change.

# Strengthening Local Civic Leadership ⑦ \$ 17,500

To promote youth engagement in local decision-making and counter anti-democratic narratives, the organization will run civic education workshops for civil society actors and youth leaders in two provinces and work with university lecturers to implement the program and build a network.

# Building a Network of Democracy Advocates ① \$ 109,000

To strengthen a network of civic and political leaders in the diaspora, the organization will host conferences and workshops for Afghan civil society leaders, political figures, media personalities, and youth leaders to encourage national dialogue and cooperation in support of democracy, civic space, and human rights.

# Providing Independent Local News ⑦ \$ 23,500

To ensure the availability of independent news and information for the citizens of Balkh province and enhance the capacity of an independent media organization, the organization will operate an independent FM radio news channel, featuring a wide range of programs on political, economic, and social affairs in Balkh.

# Promoting Youth Engagement ® \$50,000

To strengthen youth civic engagement in northern Balkh province, the organization will support community-based youth organizations in assessing local needs, advocating for access to public services, and representing communities at the provincial level, while holding civic and community dialogues to foster local engagement in decision-making processes.

# Supporting Democracy Advocates-at-Risk ® \$70,000

To bolster support for democracy advocates-at-risk and enhance their ability to adapt and continue their work, the organization will facilitate fellowships for scholars, journalists, writers, human rights defenders, and civil society leaders who had to flee the country, while providing modest financial support to improve their mid-to-long-term resettlement prospects.

# Strengthening Local Women Journalists ② \$44,000

To enhance the capacity of a women-led news agency and expand the availability of news and analysis, the organization will provide independent news analysis in Dari, Pashto, and English on its website and social media, focusing on women's political rights and human rights.

# Defending Women's Rights ① \$ 60,000

To promote women's rights and facilitate access to justice for women facing persecution, the organization will provide legal aid and advice to women in three provinces and hold advocacy meetings to promote the enforcement of legal protections for Afghan women under the current justice system.

# Advancing Women's Judicial Rights Through Legal Training and Advocacy ① \$ 50.000

To enhance the capacity of women professionals to promote women's judicial rights and access to justice, the organization will provide legal training and mentorship in four provinces, establish a network for collective advocacy, and conduct research on the challenges women face in seeking justice, sharing findings with local and international human rights organizations.

# Promoting Democratic Values and Supporting At-Risk Artists ① \$ 100.000

To protect and promote the rights of artists and foster collaboration between them and civic activists for collective advocacy efforts, the organization will support and mentor a network of artists and activists by organizing workshops, networking events, and promoting collective advocacy initiatives to promote democratic values.

# Protecting Women's Political Rights ① \$ 60.000

To empower women activists and protect women's political rights, the organization will monitor the human and women's rights situation across the country through its local network, produce monthly and quarterly reports, and hold home-based classes in two provinces to provide safe spaces for women to network and collaborate on women's rights.

# Promoting Civic Values on Local Radio ① \$ 55,000

To strengthen local independent media and promote democratic ideas and civic values, the organization will produce and broadcast civic programs on political, economic, and social issues in Dari and Pashto on its FM radio channel, while training reporters and journalism students.

# Empowering Women Journalists and Promoting Women's Political Rights 1 \$ 50.000

To provide independent news content and maintain women's participation and representation in the media, the organization will provide women journalists a platform through its FM radio network to produce and broadcast news on women's political issues and advocate for women's rights and freedom of expression.

# Preserving Freedom of Expression and Access to Information ① \$ 200.000

To support freedom of expression and provide accurate, timely, and reliable information, the organization will produce and publish online news, investigative reports, and analytical pieces in Dari and Pashto, promote citizen journalists, and release regular monitoring reports on the repression of journalists and media.

# Sustaining and Supporting Independent Media ① \$ 300,000

To expand the availability of news and strengthen the sustainability of independent media, the organization will deliver independent news and reports in Dari, Pashto, Uzbek, and English on democracy, human rights, and accountability, while livestreaming daily news in Dari and Pashto and hosting discussions to promote freedom of expression and information.

# Supporting Independent Pashto-Language Media ① \$ 55.000

To expand the reach of independent media in southern Afghanistan, the organization will maintain and enhance its multimedia online platform, produce daily news reports and analysis in Pashto, and stream social and cultural programs promoting democratic ideas and civic values.

# Documenting Human Rights Abuses ® 110.000

To defend human rights and monitor violations of international humanitarian law, the organization will document, map, and report on cases of extrajudicial killings, forced disappearances, illegal detention, and human rights abuses of Afghan citizens, conduct a public perception, and advocate for accountability and adherence to international humanitarian law.

# Promoting Public Policy and Debate ① \$ 180,000

To strengthen informed public discourse and democratic policy debate, the organization will bring together civil society leaders, democratic actors, academics, and regional and international stakeholders to discuss Afghan and regional issues, while producing research papers to encourage policy analysis and public debate.

# Promoting Democratic Values and Pluralistic Leadership \$\mathbb{Q}\$ \$70,000

To empower youth and women leaders and foster pluralism, the organization will hold seminars at universities to promote democratic values, expand its network of women youth leaders for advocacy on women's political rights, organize youth debates, and produce podcasts to promote pluralistic ideas and initiatives.

# Supporting Local Women Journalists ② \$ 43,500

To enhance the capacity of a media organization to report on the conditions of women's rights in western Afghanistan, the organization will provide news in Dari and Pashto languages on its website and social media, and produce podcasts for women to share their experiences under Taliban rule.

# Supporting Independent Local Media @ \$ 47.000

To support independent media, the organization will produce and broadcast news and programs on political, economic, and social affairs through its FM radio, while training reporters and university journalism students.

# Empowering Women Through Research, Training, and Advocacy ® \$130.000

To strengthen women's engagement in policy research and advocacy, the organization will publish an annual peer-reviewed public policy journal, train women students and professionals to develop policy briefs, and conduct bimonthly surveys to ensure women's perspectives are reflected on national issues.

# Strengthening Youth Entrepreneurship ① \$ 40,000

To instill in youth an awareness of the values of entrepreneurship, market economics, and democracy, the organization will implement its entrepreneurship curriculum in high schools across four provinces, train teachers, organize business proposal competitions, and offer two business start-up courses for students.

# Defending Women's Political Rights ① \$ 120.000

To promote women's political rights and amplify their voices at local and international levels, the organization will host panel discussions with women civil society leaders, conduct advocacy meetings with international stakeholders, and engage Afghan activists from inside and outside the country.

#### Promoting Public Debate and Youth Agency ® \$ 90,000

To facilitate debate on a future democratic vision and promote youth participation in public life, the organization will use its digital platform to host talk shows, produce documentaries on positive social change, and provide a space for youth to engage in debates about the country's democratic future.

# Maintaining Space for Women Journalists **45,000**

To enhance the capacity of a women-led news agency and provide space for women journalists in Afghanistan, the organization will maintain a news agency providing independent news and analysis on women's political rights, human rights, and accountability, and host virtual seminars for women journalists on online journalism, investigative reporting, photojournalism, and media advocacy.

#### Promoting Democratic Values and Principles **4** \$ 50.500

To support a professionals' forum in Herat province, the organization will conduct research projects on democratic values, provide leadership training for university students and civil society actors, and publish a daily news bulletin and monthly magazine focused on local affairs.

# Strengthening Grassroots Women's Political Rights Organizations **4** \$ 94.000

To defend and promote women's political rights, the organization will strengthen civil society groups by enhancing their capacity, facilitating collaboration, and supporting their participation in international forums while developing institutional capacity and risk mitigation plans.

To promote critical thinking and strengthen leadership skills among university students, the organization will conduct leadership and advocacy trainings, organize online debate tournaments, and support youth in leading collective advocacy efforts for marginalized communities.

To promote accountability around human rights abuses, the organization will publish periodic reports on violations, produce reports on forced eviction and displacement, and advocate for greater accountability through outreach to the public, civil society organizations, and multilateral agencies.

# Documenting and Archiving Human Rights ① \$ 50,000

To strengthen access to information on human rights violations, the organization will collect and archive government, independent, and public records on politically motivated abuses, disseminate analytical reports for civil society advocacy, and conduct a training on data collection and verification for other organizations.

# Supporting Strategic Litigation to Promote Reform <sup>(1)</sup> \$ 64,400

To enhance access to justice in human rights cases, the organization will strengthen a sub-national network of human rights lawyers, train them to target strategic cases, support their work locally and nationally, and produce an analytical study on their experiences and challenges.

# Supporting Independent Media ① \$ 45,000

To support a media initiative providing news and investigative reports, the organization will produce in-depth reports and articles on political, economic, and social developments, offering a platform for independent journalists whose work is marginalized or censored in mainstream media.

To strengthen access to information on corruption and approaches to combating it, the organization will support an independent digital platform for disseminating information on corruption, transparency, and democratic transitions, facilitate public debate, and sponsor a fellowship program to train young investigative journalists and place their work with independent outlets and think tanks in the MENA region.

To facilitate informal sector workers' establishment of independent unions, the organization will conduct training on union management, electoral campaigns, and running for office in labor organizations, convene seminars to raise awareness of informal sector workers' issues, and provide legal representation and consultation to defend their social, cultural, and economic rights.

To defend media freedom and the rights of media professionals, the organization will provide legal defense for journalists facing legal prosecution, monitor the implementation of the policy agenda set by the journalists' syndicate through a digital platform, and provide regular updates to civil society and syndicate members to inform advocacy campaigns.

# Supporting Independent Media ① \$ 70,000

To support independent news that reflects citizens' interests, the organization will mentor and train contributors, publish content from citizen and professional journalists, and create space for politically diverse voices in its reporting.

# Supporting Accountability in Detention Centers (2) \$ 68,800

To protect human rights and support greater accountability and oversight of detention centers, the organization will conduct a study on the treatment of prisoners in new prison complexes, publish and expand mapping efforts on violations in detention facilities, and review and update its human rights monitoring and advocacy strategy.

To enhance public understanding of candidates, platforms, contexts, norms, and processes in elections, the organization will establish an online resource center and produce text and multimedia content covering debates on election laws, candidates' policies, party and union officials' stances, and the management of electoral contests for national and subnational elections.

To revive attention on and promote a foundation for transitional justice, the organization will lead strategic litigation to activate a constitutional provision for a transitional justice commission, conduct research, publish reports, and organize multistakeholder discussions to reignite public and civil society interest in the topic.

To support and defend journalists and media freedom, the organization will monitor the rights of media professionals and organizations, provide updates on violations and developments related to press freedoms, and publish monthly and annual reports on its website and social media to inform advocacy and support legal efforts for press freedom.

To strengthen local governance and defend the rights of civil society activists, the organization will engage lawyers, local leaders, civic groups, unions, politicians, and administrators in discussions around development goals, deliver an evaluation of the government's priorities, and produce an annual report on local democracy summarizing civic freedom and representation indicators.

To support and strengthen independent media, the organization will train and mentor young journalists, provide material and logistical support, and help them produce professional-quality media content for independent outlets.

To advocate for detainees' human rights, the organization will identify pressing issues facing political prisoners, file cases on medical negligence, and produce a report and social media content to raise public awareness.

# Promoting Rights of Religious Minorities and Youth Participation @ \$ 35.000

To empower and strengthen civic engagement among youth and religious minorities, the organization will provide training on anti-discrimination and access to justice, while holding coordination meetings and workshops on citizenship and civic participation.

# Strengthening Investigative Journalism ① \$ 66,200

To strengthen investigative journalism, the organization will mentor journalists through a seven-month residential fellowship, hold virtual workshops on advanced investigative techniques, support fellows in conducting accountability-focused investigations in MENA, and facilitate participation in its annual forum and an international networking event.

# Strengthening Independent Reporting on Corruption ® \$250,000

To strengthen anti-corruption reporting and build local journalists' investigative capacity, the organization will lead investigations on public trust violations, mismanagement of funds, and abuse of power while mentoring journalists in data gathering and reporting.

# Strengthening Community Radios ② \$ 150.000

To strengthen independent community media, the organization will lead a capacity-building initiative for community radios in Tunisia, Morocco, Algeria, and Libya, facilitate regional exchanges and networking, provide mentorship on content production, and support a regional network advocating for legal reforms.

### Promoting Understanding of Grand Corruption and its Impact on Democracy ① \$ 208,400

To promote understanding of grand corruption elites' impact on democracy in the MENA region and foster collaboration between Arabic-speaking media professionals and international experts, the organization will produce videos on middlemen and enablers facilitating illicit financial flows and evading anti-money laundering protocols.

# Advancing Democratic Development Through Intergenerational Learning ① \$ 100.100

To enhance youth civic engagement and facilitate intergenerational learning, the organization will host online discussions and training sessions between youth and senior activists, and organize an inperson regional youth camp to develop leadership skills and strengthen connections between experienced activists and young participants.

# Promoting Accountability Through New Media and Technology ® \$63.600

To strengthen civil society groups' ability to monitor political processes and promote government accountability using new technology, the organization will build capacities through its regional fellowship program and support a regional alumni network to enhance collaboration on technology and governance.

# Strengthening Civil Society's Engagement with Mechanisms to Promote Accountability ① \$80.500

To develop civil society organizations' capacity to leverage International Finance Institution (IFI) mechanisms for accountability and civic space protection, the organization will provide analysis on IFI activities to CSOs in eight MENA countries, facilitate their engagement with IFIs and governments, and equip them with advocacy tools and methods.

### Strengthening Youth Leadership in Public Policy ① \$ 42,500

To engage emerging leaders in shaping public policies on good governance and socioeconomic rights, the organization will support young researchers through skill-building and experience exchange, develop policy recommendations, produce analytical papers, create training kits, and train civil society organizations on socioeconomic issues.

# Enhancing Constitutional Law, Institutions, and Processes @ \$ 122.600

To strengthen expertise on rule of law and constitutional governance, the organization will host an annual academy for scholars, jurists, and decision-makers, mentor participants in developing policy papers, and support activities promoting their policy recommendations.

# Supporting Human Rights Advocacy ® \$ 57.000

To broaden public dialogue on human rights through film festivals and strengthen a regional advocacy network, the organization will provide expertise on using films for human rights advocacy, facilitate cooperation among member organizations, and offer research tools and resources to the human rights film community.

# Establishing a Regional Movement for Women's Political Empowerment @ \$ 70.000

To strengthen women's political representation and leadership through regional learning and solidarity, the organization will organize a conference for women leaders from the Middle East and North Africa, conduct research, and publish a report with recommendations and a regional roadmap for enhancing women's political participation.

# Supporting Dialogue on Contentious Political and Economic Issues ① \$ 100.000

To assess and strengthen pro-democracy and reform movements, the organization will conduct virtual dialogues and in-person workshops with civil society and political activists on economic, security, and political trends, and produce reports with key takeaways and recommendations for advancing reform efforts.

# Challenging Authoritarian Narratives ® 100.000

To promote democratic values and counter authoritarian narratives, the organization will produce storytelling-style video documentaries and podcasts in Arabic that challenge portrayals of authoritarianism as essential for political stability and economic prosperity.

# Amplifying the Impact of Investigative Journalism ② \$ 67,000

To stimulate public dialogue on investigative findings, the organization will produce video podcasts amplifying issues from independent media investigations, increasing awareness and visibility on transparency, accountability, corruption, mismanagement, and human rights.

# Protecting Human Rights Defenders ® \$116,800

To protect at-risk human rights defenders in Egypt, Libya, Syria, Tunisia, and Algeria, the organization will provide rapid financial assistance, facilitate engagement with human rights stakeholders, and offer coordination and mentoring services to sustain their activities.

# Advancing Data-Driven Policy Through Public Opinion Research ® \$117,500

To promote evidence-based policy and strengthen civil society's polling capacity, the organization will implement public opinion surveys in Mauritania and the West Bank and Gaza, publish reports, host events on findings, and train local partners in survey methodologies and data utilization.

# Supporting Electoral Reform <sup>(1)</sup> \$ 95,700

To strengthen civil society organizations' ability to influence electoral reform and improve electoral processes and participation, the organization will produce multimedia content, including short videos, to promote regional understanding of elections, host roundtables, training sessions, and monitoring missions, and produce reports with recommendations and advocacy strategies for reforms.

# Engaging Policy Makers on Economic Reforms ② \$ 130,000

To enable MENA leaders to engage in economic policy reforms and risk analysis, the organization will host two regional academies on policy formulation, produce and disseminate analytical publications, lead advocacy efforts, and convene a regional policy forum to present key recommendations.

# Promoting Media Reform ② \$ 125,000

To support media freedom and independence through legal reform in the Maghreb region, the organization will convene civil society groups to monitor media regulations, train journalists and lawyers on freedom of expression laws, and provide legal assistance to journalists and defenders in Libya.
