World Movement for Democracy

he World Movement for Democracy, initiated by NED in 1999, is a global network of activists, practitioners, scholars, donors and others engaged in advancing democracy around the world. Through electronic networking, regional meetings, global assemblies and special projects, the World Movement facilitates the sharing of knowledge, information and experiences to help enhance the work of its participants and thus leverage the support provided by democracy assistance organizations like NED.

Sixth Assembly

On April 11–14, 2010, the World Movement for Democracy held its Sixth Assembly in Jakarta, Indonesia. The Assembly brought together a richly diverse group of some 550 participants representing every region of the world. Through panel discussions, dozens of workshops, and informal dialogue, they taught and learned from each other and developed collaborative relationships, thus strengthening the World Movement as a global network committed to mutual support, exchange and solidarity. Under the theme of "Solidarity Across Cultures: Working Together for Democracy," the Assembly fostered discussions on cross-border solidarity, protecting minority rights, preventing electoral violence in multi-ethnic societies, building interfaith coalitions, and using civic education to instill democratic values. Discussions also focused on youth engagement and empowerment; freedom of association, assembly and expression; making democracy work by ensuring accountability and transparency and by building sustainable institutions; and best practices

in democracy assistance. Participants also held regional workshops and engaged in a variety of technology training sessions.

The Assembly opened with welcoming remarks from the Right Honorable Kim Campbell, former Prime Minister of Canada and chair of the World Movement Steering Committee, and

Bambang Harymurti, the member of the Committee from Indonesia. President Susilo Bambang Yudhoyono presented the keynote address. The Honorable Anwar Ibrahim, former Deputy Prime Minister of Malaysia and current parliamentary opposition leader, delivered an opening address, which was followed by presentations by World Movement participants Esraa Rashid (Egypt) and Tapera Kapuya (Zimbabwe), and by Steering Committee member Hans Tippenhauer (Haiti).

A highlight of each Assembly is the concluding John B. Hurford Memorial Dinner at which the World Movement presents its

Democracy Courage Tributes. At the Sixth Assembly, Courage Tributes were presented to the Movement for Human Rights in Syria, the Youth Movement in Venezuela, the Women's Movement in Iran, and the Human Rights Defenders in the North Caucuses.

Defending Civil Society Project

In 2007, the World Movement launched the Defending Civil Society project to respond to growing governmental restrictions on the space in which democracy and human rights organizations carry out their work. In February 2008, following in-depth research and consultation with hundreds of civil society groups, the World Movement, in partnership with the International Center for Not-for-Profit Law (ICNL), published the *Defending Civil Society* report, which articulates a set of long-standing principles, rooted in international law, that ought to inform proper governmentcivil society relations, and includes examples of violations of those principles.

Since publication, the World Movement, in partnership with ICNL, has facilitated numerous discussions and produced reports on the situations in a wide variety of countries. The World Movement and ICNL have also worked closely with civil society initiatives in several countries, such as Azerbaijan, Ecuador, Kenya, Mongolia, Sierra Leone and Zimbabwe, not only to help build local capacity to respond to the challenges, but also to facilitate engagement with government, where possible, to improve legal frameworks.

In an effort to help bring civil and political society together to advance reforms, the World Movement and ICNL joined several other nongovernmental networks and organizations, as well as democratic governments, in a Working Group on Enabling and Protecting Civil Society of the Community of Democracies, a global intergovernmental initiative that seeks to strengthen democratic norms and institutions around the world. Since its inception in 2010, the Working Group, chaired by the government of Canada, has developed a mechanism for alerting an international contact group on developments concerning legal environments for civil society, particularly proposed laws on NGOs, and to mobilize an international response. The Working Group's efforts also contributed to the recent establishment of the UN's Special Rapporteur on Freedom of Association and Assembly.

Democracy Assistance Project

As a result of discussions at the Fifth Assembly, the World Movement initiated a project to highlight perceptions of international democracy assistance by recipients and other key players in the field, and to develop ideas for making the funding and technical assistance more effective. The Democracy Assistance project consists of an online survey of some 1,500 activists worldwide conducted by the World Movement during 2010; 16 country case studies and a report synthesizing their findings that was contributed by the Madrid-based think tank FRIDE; profiles of various actors in the field of democracy assistance, also contributed by FRIDE; and a statement of the World Movement Steering Committee offering recommendations to donors and policy makers drawn from both the results of the reports and the members' own experiences. The World Movement is undertaking discussions with donor organizations and government representatives to help advance the findings and recommendations of the project.

Networking Highlights

In February 2010, the African Democracy Forum (ADF) and its member, IDASA: An African Democracy Institute, jointly launched a campaign to encourage African states to ratify the African Charter on Democracy, Elections and Governance. The Charter offers a unique opportunity for stakeholders to consolidate democratic gains they have made and to ensure democratic practices by governments in Africa. At the time of the campaign launch, only four countries had ratified the Charter. Since the launch, an additional six countries have ratified. For the Charter to come into force, ratification by at least 15 African Union member states is required.

In 2010, the **World Youth Movement for Democracy** significantly expanded its membership and activities. The Youth Movement held elections for a newly created Leadership Board and subsequently launched its Democracy Ambassadors Project to help develop local leadership in countries around the world. On October 18th, World Youth Day for Democracy, young people held events in 33 countries to encourage youth civic engagement to highlight youth efforts to advance democracy and to raise awareness about those at risk. Activities included art contests, democ-

racy hikes, meetings with local government officials, and peace marches, among others.

The World Movement Secretariat also worked in 2010 to develop the East Europe and Eurasia Networking Initiative. In the last year, a regional listserv was expanded and communications among participants increased. A section of the Central and Eastern Europe and Eurasia website called "Spotlight on Human Rights" was greatly expanded, providing country summaries, alerts, reports and links to local human rights organizations in the region. It is available in English and Russian. In April 2010, at the World Movement's Sixth Assembly, a regional networking workshop focused on attacks on human rights and fundamental freedoms.
